## WHAT IS THE FIXED FEE DIVORCE PACKAGE AT STOWE?

- Issue the application to the court

- Deal with any response from the other party
- Prepare and issue the application for the conditional order
- Prepare and issue the application for the final order

#### Divorce as the respondent – £375 +VAT:

• An initial options meeting with your solicitor

After which we will:

- Review the divorce application from the other party
- Complete the Acknowledgment of Service
- Deal with the conditional order
- Advise on the impact of the final order

This package covers the legal process of divorce only.

If your situation involves the need for financial settlements, making arrangements for children or has any difficulties, your divorce will be more suited to our hourly-rate packages.

#### Terms and conditions apply

Our divorce advice is limited to proceedings that are commenced in England and Wales.

Your spouse will complete the Acknowledgment of Service and return it to the court promptly. If it's necessary to apply for deemed or substituted service or use a process server, additional costs will be incurred.

There is no disputed application for costs by either party.

Neither party seeks to rescind, appeal against, delay or prevent the Conditional or Final Order.

If you are the respondent, you will not bring an application for the final order.

#### **Exclusions**

This fixed-fee package covers the legal process of divorce only and does not cover any advice or issues concerning children or finances whilst dealing with the divorce.
